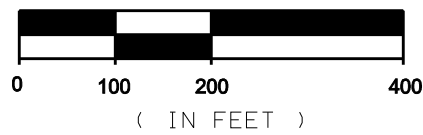


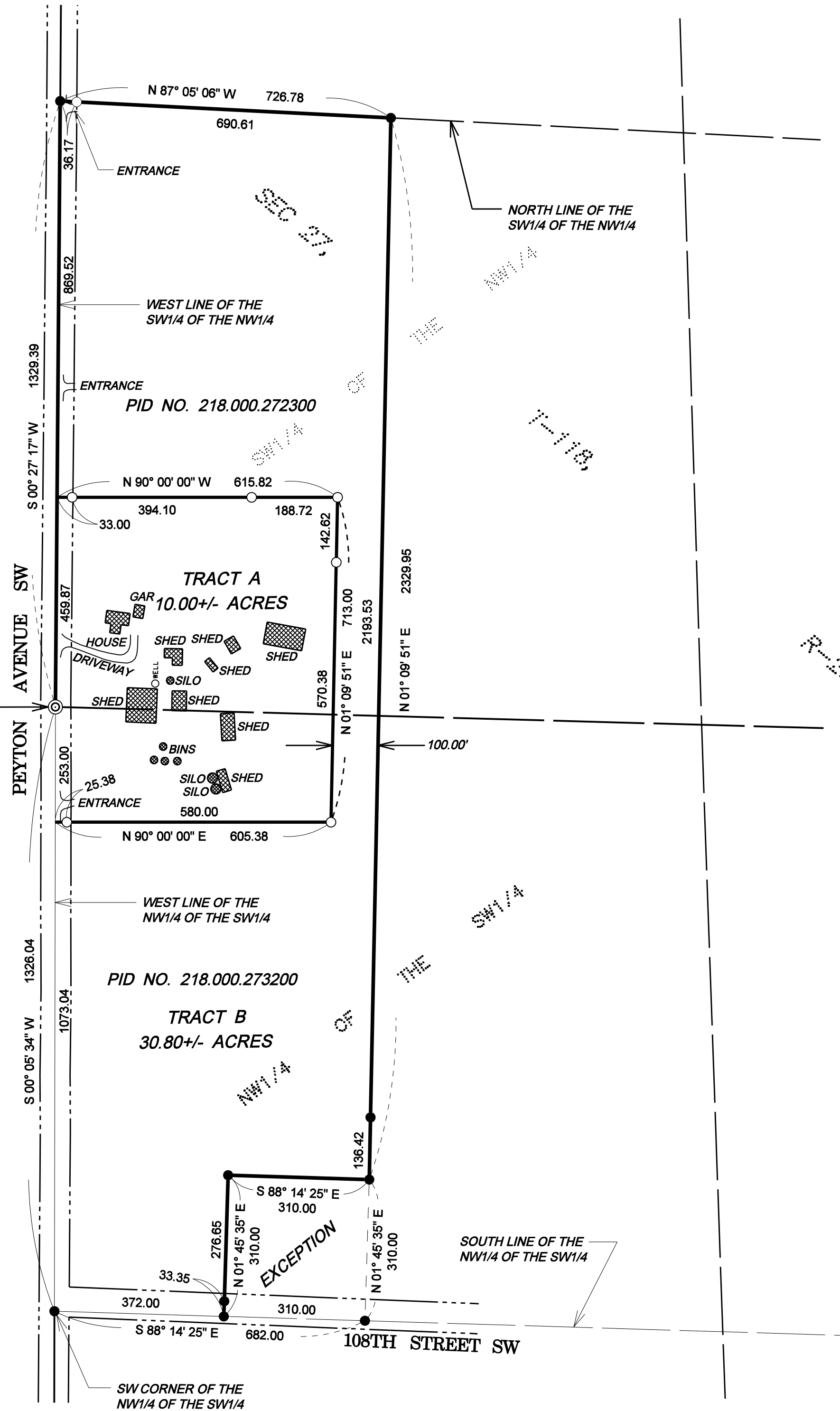
GRAPHIC SCALE

That part of the Southwest Quarter of the Northwest Quarter (SW1/4 of the NW1/4) and that part of the Northwest Quarter of the Southwest Quarter (NW1/4 of the SW1/4) all in Section 27, Township 118 North, Range 28 West, Wright County, Minnesota, described as follows: Beginning at the West Quarter corner of said Section 27; thence on an assumed bearing of South 00 degrees 05 minutes 34 seconds West along the west line of said NW1/4 of the SW1/4 for 253.00 feet; thence North 90 degrees 00 minutes 00 seconds East for 605.38 feet; thence North 01 degree 09 minutes 51 seconds East for 713.00 feet; thence North 90 degrees 00 minutes 00 seconds West for 615.82 feet to its intersection with the west line of said SW1/4 of the NW1/4; thence South 00 degrees 27 minutes 17 seconds West along last said line for 459.87 feet to the point of beginning and there terminating.
